**WHERE:** ZoiBoyz Ranch, 2115 Curtis Road, Falcon, CO 80831 .We will be in the east pasture (slight grade, 35 acres, fully fenced). Elevation is approx. 6,800'.

**SATURDAY & SUNDAY: pre-entry fee EACH DAY:** \$15 first hound / \$10 each additional hound, same household  
**Late/Gate Entry fee:** \$20 per hound. **Make checks payable to: RMBC**

**PRE-ENTRY CLOSING DATE:** Pre-entry fees and forms must be received by **6pm, Wednesday, November 9, 2016**. See entry form for details. **A minimum number of handlers must pre-enter or event will be canceled.**

**QUALIFYING RUNS:** Qualifying runs for ENTERED hounds BEFORE the Race Meet each day. Hounds with a DQ in a prior race meet ARE required to have qualifying run. First Time Entered (FTE) hounds may (but are *not* required to) have a qualifying run BEFORE the first race. Handlers must arrange a hound of the same breed for qualifying runs. Muzzles required.

**SCHOOLING RUNS:** UN-ENTERED hounds may run between programs AND after the race meet, time, weather, and equipment permitting. *Free for anyone filling positions of foul judges, line judges, boxing or handling hounds for the meet.* \$5 per hound for all others. Length of run at handlers' discretion. Muzzle may be required.

**BOX TRAINING** will be offered AFTER the race meet on Saturday: *free for anyone filling positions of foul judges, line judges, boxing or handling hounds for the meet.* \$5 per hound for all others.

**ROLL CALL & INSPECTION:** Saturday & Sunday: Track will be set up by 8:30 a.m. for qualifying runs. **Roll Call at 9:00 a.m.**  
Sunday Ribbons awarded after track is dismantled.

**REFUNDS:** Bitches in season, and lame or ill hounds will have fees refunded by mail, provided RMS is notified before roll-call.

**ELIGIBLE BREEDS:** Afghan Hounds, Basenji, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Magyar Agar, Pharaoh Hounds, Portuguese Podengos, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets. **Breed disqualifications do not apply.** All entered hounds must be at least one (1) year of age on race day, and must be registered with a NOTRA-acceptable registry. **SEE RULE BOOK FOR DETAILS** <http://notra.org> Part 1.

1. **PLEASE USE A SEPARATE ENTRY FORM FOR EACH DAY**, completed & signed. INCLUDE YOUR E-MAIL ADDRESS. A separate check for each day is preferable but not required.
2. ALL BREEDS except Irish Wolfhounds will BOX START from a 4 hole box. Well-fitted FLAT collars optional, NO TAGS or loose bits permitted.
3. Properly-fitting racing muzzles & numbered racing blankets are required. Handlers are responsible for providing proper racing equipment. No muzzle or blanket, no refund. Limited equipment is available for loan to FTE's ONLY. Please return the items between races so that others can share.
4. **For First Time Entered (FTE) hounds: you must attach a copy of your dog's registration papers to your NOTRA entry form, AND an additional one-time \$2.00 registration fee. See entry form.**
5. If your NGA Greyhound does not have an AKC, ILP/PAL, CKC, FCI or other number, please make sure **ALL** other information is filled out on the entry form, including ear tattoo numbers.
6. Hounds are checked for lameness, bitches for being in season, and muzzles for correct fit at Inspection.
7. All breeds shall run three programs, max of 4 hounds per race.
8. Any breed with  $\frac{3}{4}$  of its entry being FTE's will run ungraded races.
9. A penalty of \$5 will be assessed for any loose hound not competing in a race in progress OR causing delay of meet.
10. **Because racing is an owner/handler participation sport, EVERYONE is expected to work** to ensure the completion of the meet in as timely a fashion as possible. **A minimum number of handlers must pre-enter or event will be canceled.** We will provide on-the-job training; review rules and job descriptions before the Race Meet begins: <http://notra.org> (Part 1, "Officials").
11. There is NO shade available, bring your own. Port-a-potty and potable water available.
12. **\*\*If winds are present or forecast that prevent using Drag Lure, continuous loop will be used.**

### **FROM THE SOUTH**

1. From I-25 North, take exit 135 Academy Blvd
2. North on Academy 5.8 miles to East Platte Ave
3. Right on E. Platte 3.7 miles to Hwy 94 (direction Shriever AFB)
4. Right on Hwy 94 7.5 miles to Curtis Road (2nd light on Hwy 94)
5. Left on Curtis Road 1.9 miles to mailbox 2115 and Zoiboyz Ranch on right—it is the house surrounded by white fence on the hill. (Pass the small house on the left, continue up the hill to the house surrounded by white fence. If you come to a blinking red traffic signal at Falcon Hwy, you've gone too far north.)

### **FROM THE NORTH**

1. From 1-25 South, take exit 153 Interquest Parkway/Hwy 83
2. Go on Hwy 83 to South Powers Blvd
3. Turn right on South Powers Blvd
4. Stay on Powers to Woodmen Road Exit
5. Go left (east) ~12 miles on Woodmen to its end at Hwy 24
6. Go right on Hwy 24 0.5 miles to Meridian
7. Go left on Meridian to STOP sign at Falcon Hwy
8. Turn left onto Falcon Hwy ~3 miles to flashing yellow (Curtis Rd)
9. Turn right (south) onto Curtis Road for 4.4 miles to mailbox 2115.
10. Turn left to Zoiboyz Ranch (NOTE: This will be the 2<sup>nd</sup> driveway on left after Davis Road. Pass the small house on the left, continue up the hill to the house surrounded by white fence. If you come to a traffic signal at Hwy 94, you've gone too far south.)

### **FROM THE EAST**

1. From 1-70, take exit 359 (US Hwy 24) 54 miles to Falcon Hwy
2. Left (east) on Falcon Hwy 3.3 miles to Curtis Road
3. Right (south) on Curtis Road 4.4 miles to mailbox 2115.
4. Turn left to Zoiboyz Ranch (NOTE: This will be the 2<sup>nd</sup> driveway on left after Davis Road. Pass the small house on the left, continue the hill to the house surrounded by white fence. If you come to a traffic signal at Hwy 94, you've gone too far south.)

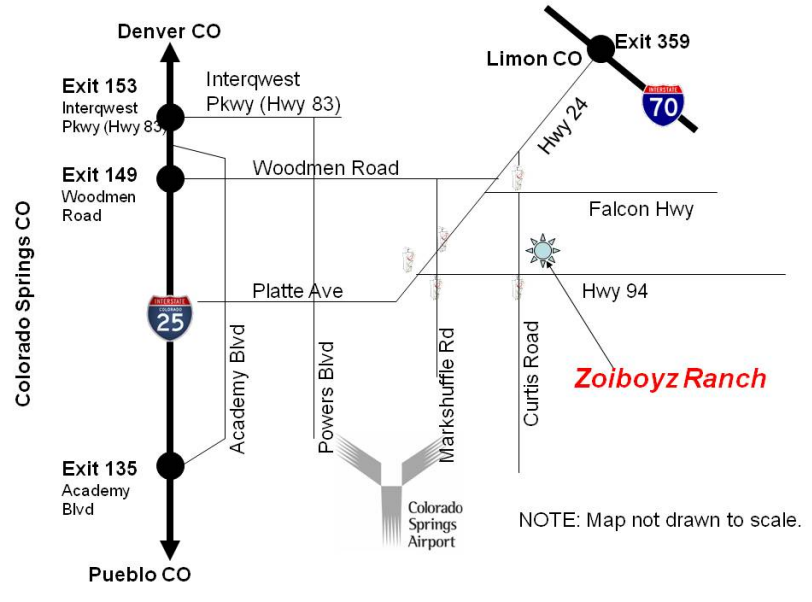
